**Item No. 6:** Approval of examination pattern and structure for UG and PG programmes as per NEP-2020.

**Resolution No.6:** Assistant Professor Sadashiv Puranik provided and elaborated the examination pattern for UG and PG programmes as per NEP-2020, prepared by the Examination Committee. Dr. Arun Magar has given valuable inputs about summative and formative type of assessment, during the preparation of the examination pattern. Prof. Dr. Vikas Kakade, Prof. Dr. Sanjay Kale and Dr. Vijaykumar Shinde have also added some inputs during the discussion in the meeting. Dr. Puranik provided the following Examination Pattern: For UG and PG programmes Summative and Formative type of assessment will be undertaken. Total marks for each course shall be based on continuous assessments (internal) and semester end examinations (external). There will be uniform pattern of 40:60 for Continuous Assessment Tests (CAT) and Semester End Theory examinations respectively and 50:50 for CAT and Semester End Practical examinations respectively. Further it was decided to adopt and implement the Examination and Assessment process guidelines provided in the Prof. R. D. Kulkarni's Report (i.e. Chapter-IV Examination and Assessment Process and Multiple Exit Path for multidisciplinary Four Year Degree and Five Year Integrated PG Programme in line with NEP-2020).


