##### In collaboration with TATA Croma, Baramati

E-Waste is growing environmental and health hazard and discarded e-waste is a serious challenge before humanity. Due to advancement in technology and consumption driven mindset, there is a tremendous demand for e materials from all the section of society. Once become damaged, these electronic goods are thrown away without proper disposal. It would be really appreciable if you provide following things for driving this campaign effectively:

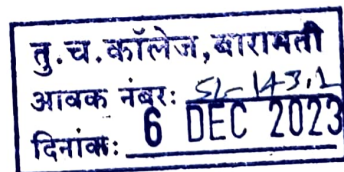

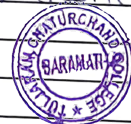

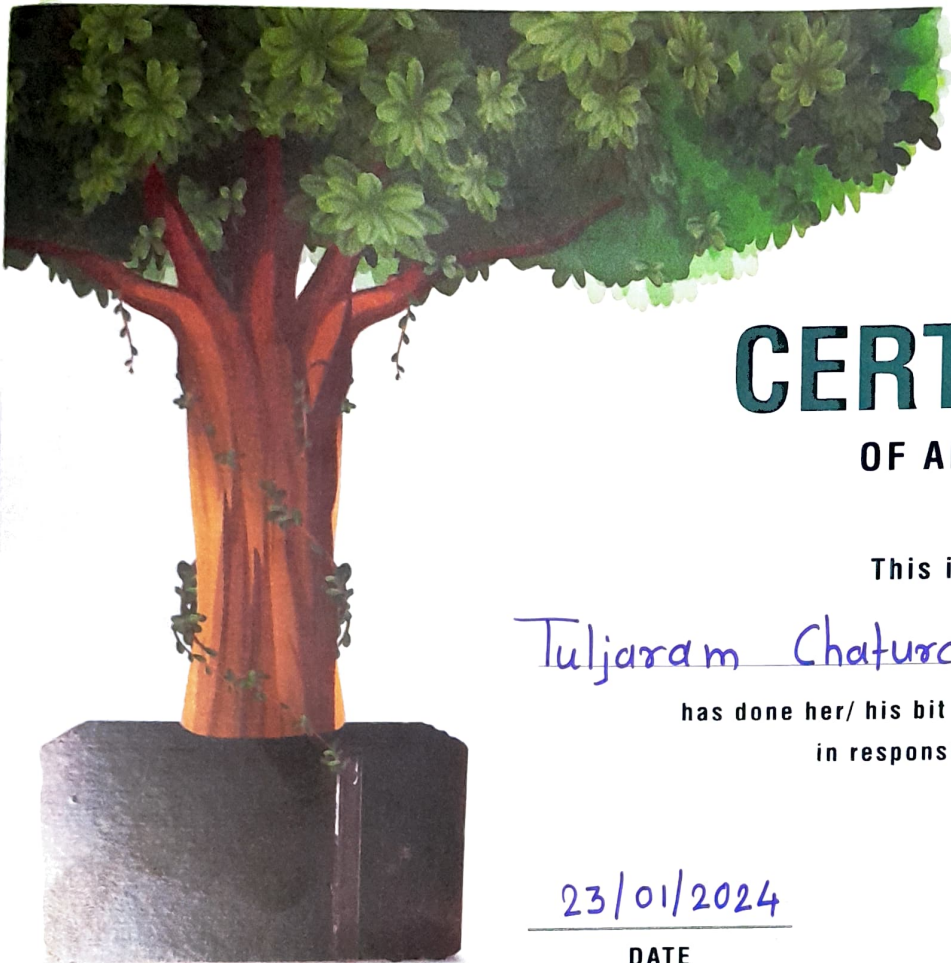
