As per the Notice no. 207, dated 15/08/2019, issued by the college, the meeting of Board of Studies in History was successfully held on 13th September, 2019 at 11:00 am in the Department of History, T. C. College, Baramati. The meeting took place both online and offline, adhering to the guidelines and protocols set by the college under the guidance of Dr. Sandeep S. Tardalkar, Chairman of the Board of Studies in History, the meeting commenced with a warm welcome to all the esteemed members, followed by a brief introduction of the meeting's objectives.

During the meeting, fruitful discussions were held on the items mentioned in the circulated agenda. We are pleased to inform you that the following resolutions were made during the BOS meeting.

1. To confirm the minutes of the previous meeting held on 09/04/2019

Dr. Sandeep S. Tardalkar read the minutes of the BOS meeting held on 9th April 2019 and put forward to the BOS members for the approval.

Resolution No. 1: The minutes of the previous Board of Studies meeting were approved and confirmed.

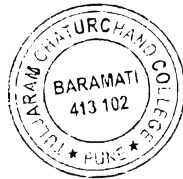
Resolution No. 4: Considered and Approved
