1. To confirm the minutes of the previous meeting held on Wednesday, 11th March 2020.

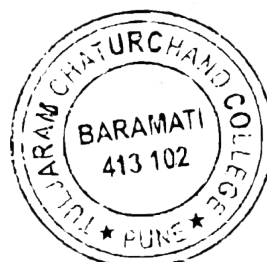
