Prof. Vivek A. Bale read the minutes of the BOS meeting held on 11th March 2020 and put forward to the BOS members for the approval.

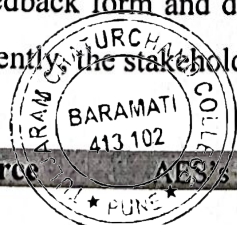
Resolution No. 1: The minutes of the previous Board of Studies meeting were approved and confirmed.

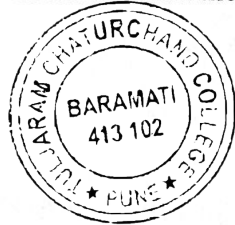
