1. To confirm the minutes of the previous meeting held on 11th May 2020.

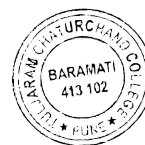
Ms. S. S. Sonawane read the minutes of the BOS meeting held on 11th May 2020 and put forward to the BOS members for the approval.

Resolution No. 1: The minutes of the previous Board of Studies meeting were approved and confirmed.

2. To design and approve curriculum of T.Y.B.Sc Semester-V (2019 pattern) to be implemented from the academic year 2021-2022.

The board carefully designed and deliberated upon the curriculum of T.Y.B.Sc. Semester-V, aligning it with the guidelines of the 2019 pattern, for implementation in the academic year 2021-2022. During the meeting, Ms. S. S. Sonawane presented the curriculum of courses and credit structure, and the recommendations and valuable insights provided by the BOS members were thoughtfully incorporated into the curriculum.

During the discussion, certain modifications were suggested by the board members. Dr. V. B. Shimpale proposed to add role of National Biodiversity Authority and State Biodiversity Authority in the course EVS3504: Nature Conservation. Dr. S. D. Kulkarni proposed to add Biomedical Waste in the course EVS3506: Environmental Biotechnology. The board thoroughly discussed and finalized the syllabus for the following courses of T.Y.B.Sc. Semester VI.
