#### 2. Review of FYBA & SYBA Syllabus-

Existing Syllabus was discussed, reviewed and approved by the board.

The Members Suggested following additions/changes in the proposed syllabus-The Common Suggestions-

- 1) Replacing दायविभाग प्रकरण
- 2) Mentioning specific names of the selections from Ramayana & Mahabharata. The Specific Suggestions by BOS Members individually-
  - 1) Dr. Mugdha Gadgil suggested to replace दायविभाग प्रकरण with करविभाग
  - 2) Dr. Bharati Balte suggested to replace दायविभाग प्रकरण with ऋणादानम्, inclusion of बुधभूषणम् as आधुनिक संस्कृत काव्य, inclusion of 5th chapter of स्वप्नवासवदत्तम्.
  - 3) Dr.Rupali Vadekar suggested a change in name, Instead of 'उपयोजित संस्कृत व्याकरण', she suggested to change it as 'उपयुक्त संस्कृत व्याकरण', Inclusion of
  - 4) Dr. Ambarish Khare suggested an inclusion of कर्णभार एकांकिका, selected portion from रूपकचतुष्ट्यम् and/or कलिविडम्बनम्.
  - 5) Pratima Waman suggested to include an introduction of various points that are covered by Dharmashastra.

Discussion in the Meeting:

Members suggested following points-

- 1. The syllabus should be easy to understand, and should content some learning values. It should also contain some core sanskrit texts.
- 2. Students should be taught Communication Skills
- 3. Need to be precise about selection of portion of Natyashastra & Dramas
