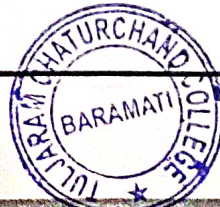



### Board of Study Meeting

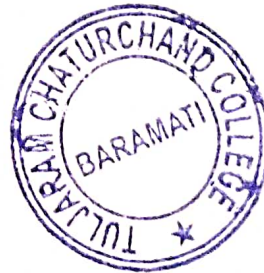

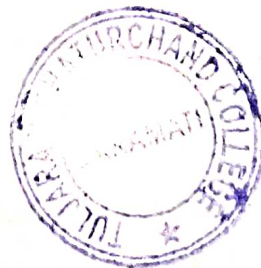

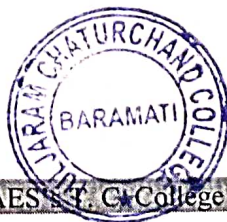

**3. To discuss and incorporate the relevant feedbacks of the stakeholders (students, teachers, parents, alumni and employers) in the curriculum.**



**Resolution No. 4:** Considered and Approved


