As per the Notice no. 207, dated 10 / 10 / 2022, issued by the college, the meeting of Board of Studies in Library and Information Science was successfully held on 13th October, 2022 at 11:00 am in the Department of Library and Information Science, T. C. College, Baramati. The meeting took place both online and offline, adhering to the guidelines and protocols set by the college under the guidance of Prof.D.V.Munguskar, Chairman of the Board of Studies in Library and Information Science the meeting commenced with a warm welcome to all the esteemed members, followed by a brief introduction of the meeting's objectives

During the meeting, fruitful discussions were held on the items mentioned in the circulated agenda. We are pleased to inform you that the following resolutions were made during the BOS meeting.
