Resolutions Passed in the Board of Studies Meeting

Date: 06th October, 2022

The meeting was held on Thursday 06th October, 2022 at 11.00AM to design and frame the syllabus under the Board of Studies, Department of Media and Communication Studies. The following resolutions were passed in the meeting with a majority.

- 1. In this session it was resolved that "News Reporting and Editing 1" theory subjects need some modification as per current scenario and which must go with upgradation of "News Reporting and Editing 2" of 3rd semester SY.B.Voc.
- After the discussion it was resolved that the syllabus should be accepted after making necessary modifications in the syllabus and also adding some industry practical oriented decisions.
- 3. After the discussion it was also resolved that the subject "Writing for Media 1", certain units has to be replaced with various writing forms.
- 4. Later necessary changes were made in the syllabus and additional units were included in the structure.
- 5. At the end of the discussion, it was said to consider that Language Skills English modules must be bifurcated into 2 categories; written English and spoken English.
- 6. The assignments have to be planned according to the industrial requirements of media for the content creation purposes.
- 7. The subject, "Content Production on Möbile", was discussed and it was also resolved that the subject syllabus should be accepted after necessary modifications.
- 8. As per the discussion Understanding Cinema of 2nd semester M.Voc Media Studies has been replaced with Basic Principles of Advertising.
- 9. The new subject syllabus for the respective paper has been prepared.
- 10. As per discussion, "Script Writing and Direction" paper name changed into "Direction"
- 11. The "Media, Society and Culture" paper was replaced by "Advance practices in Journalism".
- 12. The "Media Research Methods" paper was replaced by "Broadcast Journalism" respectively
- 13. Necessary changes were suggested for "Mobile Production" paper and that has been recorded and the required changes are done including a Unit of Live video production.
- 14. A new paper "Understanding Documentary" is also included in the M. Voc Media Studies.
