**Board of Studies Meeting**





As per the meeting of Board of Studies in Environmental Science was successfully held on 5<sup>th</sup> April, 2023 at 12:00 pm in the Department of Environmental Science, T. C. College, Baramati. The meeting took place both online and offline, adhering to the guidelines and protocols set by the college under the guidance of Ms. S. S. Sonawane, Chairman of the Board of Studies in Environmental Science, the meeting commenced with a warm welcome to all the esteemed members, followed by a brief introduction of the meeting's objectives. During the meeting, fruitful discussions were held on the items mentioned in the circulated agenda. We are pleased to inform you that the following resolutions were made during the BOS meeting.

### **1. To confirm the minutes of the BOS meeting held on 7th Oct 2022.**

Ms. S. S. Sonawane read the minutes of the BOS meeting held on 5<sup>th</sup> April 2023 and put forward to the BOS members for the approval.

**Resolution No. 1:** The minutes of the previous Board of Studies meeting were approved and confirmed.

### **2. To design and approve curriculum of S.Y.B.Sc. Semester-III (2022 pattern) to be implemented from the academic year 2023-2024.**

The board carefully designed and deliberated upon the curriculum of S.Y.B.Sc. Semester-III, aligning it with the guidelines of the 2022 pattern, for implementation in the academic year 2023-2024. During the meeting, Mr. Abhijit More presented the curriculum of courses and credit structure, and the recommendations and valuable insights provided by the BOS members were thoughtfully incorporated into the curriculum.

During the discussion, certain modifications were suggested by the board members. Dr. Asawari Jadhav proposed to add Visit to natural community in the course USES 233: Practicals Based on USES231 and USES232. Dr. Vitthal Nale proposed to change name of Unit -I and add Biological pest management in unit-II. The board thoroughly discussed and finalized the syllabus for the following courses of S.Y.B.Sc. Semester III.

Finally, in light of the constructive suggestions offered by the BOS members, the curriculum structure underwent necessary revisions. After thorough deliberation and careful





consideration, the curriculum of following courses was presented for approval during the BOS meeting.




