The Chairman initiated the discussion by highlighting the importance of incorporating feedback from both Alumni and current students in the syllabus design process. It was noted that their insights and suggestions would greatly contribute to creating a curriculum that aligns with the needs and expectations of the students. Therefore, the BOS members reviewed the feedback and suggestions given by the alumni and students and incorporated the relevant suggestions into the curriculum of F.Y.B.A., SYBA, M.A. Part I and M.A. Part II of History. **Considered and Approved.**

**ii) Minor change in syllabus of UAHS 233: History of the Modern World and UAHS 243: Glimpses of the Modern World of class SYBA.**

Dr. S.S. Tardalkar proposed for removal of 'Unit 4. World War I and Rise of Communism' from Semester III paper, namely UAHS 233: History of the Modern World and inclusion of the same in Semester IV paper UAHS 243: Glimpses of the Modern World. After thorough discussion, the proposal was approved.
