MINUTES OF THE BOS MEETING

23/10/2023

As per the Notice no. 207, dated 15/09/2023, issued by the college, the meeting of Board of Studies in English was successfully held on 19 October 2023 at 12.00 pm at the Department of English,

T. C. College, Baramati. The meeting took place in offline mode, adhering to the guidelines and protocols set by the college. A few subject experts could not attend the meeting in person; hence the syllabi were sent to them for their suggestions and approval.

Under the guidance of Dr. Shashank B. Mane, Chairman of the Board of Studies in English, the meeting commenced with a warm welcome to all the esteemed members, followed by a brief introduction of the meeting's objectives.

During the meeting, fruitful discussions were held on the items mentioned in the circulated agenda. We are pleased to inform you that the following resolutions were made during the BOS meeting.

1. To confirm the minutes of the BOS meeting held on 08 June 2023.

The minutes of the previous Board of Studies meeting were approved and confirmed.

2. To design and approve curriculum of First Year UG and PG (Sem-II) in accordance with the NEP 2020 to be implemented from the academic year 2023-2024.

The board carefully designed and deliberated upon the curriculum of FYBA Semester- II, aligning it with the guidelines of the National Education Policy (NEP) 2020, for implementation in the academic year 2023-2024. The board also carefully designed and deliberated upon the curriculum of M.A. Part-I, Semester-II, aligning it with the guidelines of the NEP 2020, for implementation in the academic year 2023-2024. During the discussion, certain modifications were suggested by the board members which are as follows:

- 1. Phonology of English II (FYBA): it was suggested that since the Sem I syllabus is bit lengthy, some of the Sem I syllabus part be cut and included in the Sem II syllabus. It was also suggested that when making the syllabi of SYBA and TYBA in the future according to NEP 2020, this paper should be continued.
- 2. English for Practical Purposes II (FYBA): it was suggested that 'Review of movies' and 'What is literature and what is not' should be included.
- 3. English Literature from 1798-2000 II (MA I): it was suggested that a Victorian novel be incorporated to include the Victorian era.
- 4. On Job Training (OJT) it was suggested that the department should look for firms and institutions who need student-interns. It was also suggested that P.G. students could also be given 'Field Work' for four credits instead of On Job Training.



The board thoroughly discussed and finalized the syllabus for the following courses of M.A. Part-I, Semester-II. It was decided that students will be either sent for On Job Training or be given Field Work activity for 4 credits.

During the discussion, certain modifications were suggested by the board members which are as follows:

4. To design and approve curriculum of S.Y.B.Sc. (Sem-IV) (2022 pattern) to be implemented from the academic year 2023-2024.

During the discussion of the curriculum of S.Y.B.Sc. certain changes in the syllabus were suggested by the board members which is as follows:

Technical English – **IV** (S.Y.B.Sc. Computers): it was suggested that the name of paper be changed from 'Technical English' to 'English in Use'.

The BoS unanimously approved the change in the title of the course.

5. To design and approve the curriculum in accordance with the CBCS 2022 pattern for M.A. Part-II (Semester-IV) from the academic year 2023-2024.

The board carefully designed and deliberated upon the curriculum of M.A. Part-II, Semester-IV, aligning it with the guidelines of the National Education Policy (NEP) 2020, for implementation in the academic year 2023-2024. During the discussion, certain modifications were suggested by the board members which are as follows:

- 1. Indian Writing in English II (MA II): it was suggested that a more contemporary Indian novel in English be included.
- 2. American Literature II (MA II): it was suggested that the speech 'I have a dream' should be included.
- 3. Translation Studies (M.A.-II): it was suggested that a project on actual translation be included.
- 4. Creative Writing (M.A.- II): it was suggested that instead of only theory, more practical should be included.

The board thoroughly discussed and finalized the syllabus for the following courses of M.A. Part-II, Semester-IV

6. To discuss and incorporate the relevant feedback of the stakeholders (students, teachers, parents, alumni and employers) in the curriculum:
