Conditional permission is being granted.

1. Additional admissions of 10% of the sanctioned admission capacity to the above courses should be given as per merit, reservation rules.
2. In the academic year 2020-2021, the list of students admitted under merit reservation and rules (the final list according to aided and unaided batch) should be submitted to the Department of Academic Receipts and Provisions.
3. Additional admission capacity is also for the academic year 2020-2021 and no new batch or new additional post will be sanctioned to any college due to increased capacity.
4. 10% additional admission if it is found that other colleges in the area are adversely affected. The decision taken by the University Authority Board regarding admission will be binding on the college.
5. Fees of 10% additional admitted students in subsidized blocks should be charged as per students in subsidized blocks to know.
