Sir,

According to the order received in accordance with the above subject and reference letter, your college will offer first year 8.5c for the academic year 2022-2023 only. Computer Science, B.B.A., B.B.A. (Computer Application), admission of additional students to the extent of 10 per cent of the original student intake capacity (excluding all fast-track sections) is being permitted to this degree/postgraduate coveringent is full even of the tolowing term and continue.

- In the academic year 2022-2023, courses which are not centrally admitted. 10% additional admissions are being given to such committeral courses. Traditional.
- 2. If application received from CBSC/ICSC and Central Board students, additional admissions should be indee only from those students, who have appeared and passed the Central Board (CBSC/ICSC) Class 12 examination based on merit. Also, Class 12th passed students of other Boards other than Central Board who have been previously admitted to the concerned college, have lower than the marks of the students admitted to the lowest marks in the merit list of that category (cutoff). Students with merit should not be given admission to these additional years. An additional
- 3. admission of 10% of the sanctioned admission capacity to the above courses should be given as per merit, reservation and rules.
- 4. In the academic year 2022-2023, the flut of students admitted according to mark, reservation and rules (final flat of aided and unaided batch wise) should be submitted to the Educational Qualification and Education Department.
- The additional admission capacity is only for the academic year 2022-2023 and no new batch or new additional post will be sanctioned to any college due to the wald capacity.
- 6. 10% additional admission was found to adversely affect other colleges in the area in terms of student intake if so, the decision taken by the University Authority Board regarding the said additional admission will be binding on the college.
- The respective college management will be responsible for providing educational and physical facilities for the additional students admitted as per 10% additional admission capacity.
- Fees of 10% additional admitted students in subsidized blocks should be charged as per students in subsidied blocks.
- If the merit list of CBSC/ICSC students in that category (cutoff) is more than 10%, then the college should submit a separate proposal to the university along with CBSC/ICSC cutoff.
