- Your Services will be governed by the Maharashtra Public Universities Act, 2016, Statutes, Code of conduct, ordinances and rules and regulations laid down by the University and State Government from time to time.
- You have to communicate your acceptance letter to the management / College / Institution within seven days from the date of receipt of this order of appointment, failing of which this appointment is liable to be cancelled.
- Your appointment is as per the terms and conditions mentioned in Government Resolution No.Sankirn-2018/(185/18)/mashi-3, dated 14/11/2018, dated 22/10/2021 & dated 27/03/2023 and from time to time.
- Your appointment will be terminated automatically after the above appointment period is over and no separate notice of termination will be given.
- Your appointment is up to the regular appointment through selection committee or for the above temporary period during this academic year **2024-25** whichever is earlier.
- You shall not leave the service before the expiry of, the above referred temporary period, unless one month's notice or in lieu of notice, payment of one month's pay to the Governing Body, as the case may be.
- Your appointment is subject to approval of the University & Govt.
- You shall submit the originals as well as certified true copies of relevant testimonials such as birth date certificate, mark sheets, experience certificate, discharge / relieving certificate, caste certificate, change of name certificate (if any), etc. before joining your duties. You have to inform correct mailing address to the head of the institution for communication.
- You have to submit medical certificate from civil surgeon / approved medical officer to prove your physical fitness.
