
Sir,

- Your services will be governed by the Maharashtra Public Universities Act 2016, Statutes, Code of Conduct, Ordinances, and Rules and Regulations laid down by the Savitribai Phule Pune University, Government of Maharashtra & P.G.K. Mandal Pune from time to time.
- Your appointment is purely temporary for the period from 02-08-2023 to 30-04-2024 (A.Y. 2023-2024)
- You are entitled to get a consolidated salary of Rs. 18000/- per month for the period from 02-08-2023 to 30-04-2024 from the management.
- Your appointment is subject to the minimum number of students & the workload available for the post.
- You will have to submit the originals as well as certified true copies of relevant testimonials such as birth date, mark sheet, experience letter, caste, change of name certificate (if any), etc., and other relevant documents before joining your duties.
- You are required to give the correct mailing address as soon as you join the duties and any change in the address given earlier should be communicated to the Principal. It will be presumed that any letter sent by Registered Post Acknowledgement Due (RPAD) at the address given or any email sent to your registered mail ID shall be deemed to have been acknowledged and duly signed by you.
- You will not conduct or engage yourself in any private tuition or private coaching classes.
- You will not engage yourself in any job paid full-time/part-time or otherwise, during the continuance of your service, without the permission of competent authority/management.
- Your appointment may be terminated at any time by either side/party by giving one month's notice or one month's pay in lieu of notice period in case the period spent in service is more than six months. Failing this above-mentioned 30 days' notice period clause, you will not be able to get any related documents, if any, and remuneration, salary for this period from the college/management.
- If you are absent continuously for more than thirty days without permission, your services will be terminated automatically. If you are found guilty of the violation of any terms and conditions mentioned above, you will be liable for disciplinary action and punishment decided by the management as provided for in the statutes. During the period of your service, you shall not directly or indirectly do such things, which are subversive to the interests of the Society/University/ Institute/College/Students.
- You have to communicate your acceptance to the Management / College / Institution within seven days from the date of receipt of this Order of Appointment failing which your appointment is liable to be cancelled.
