

Resolution No.4: Resolution is approved.




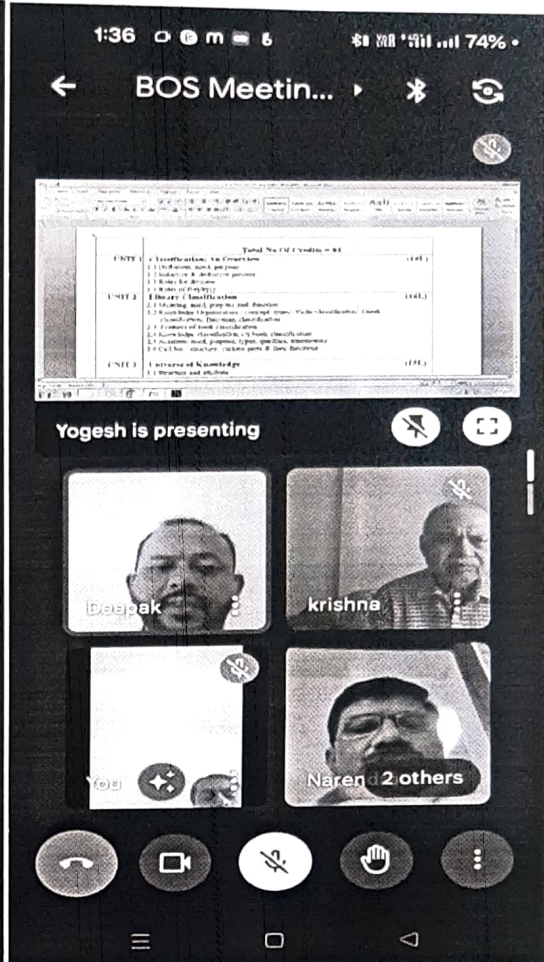
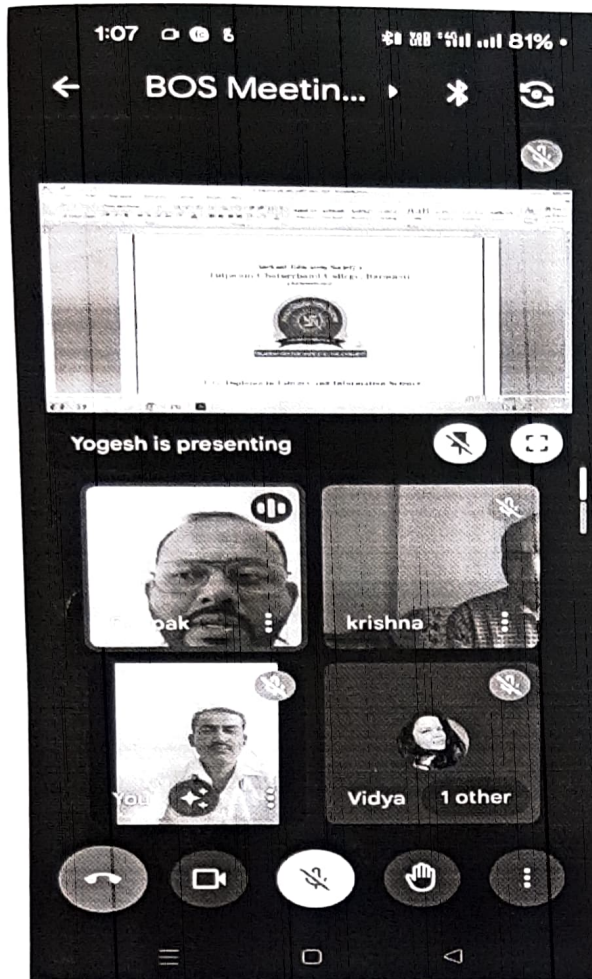
