**Details information of the Industrial visit:**

Anekant Education Society's Tuljaram Chaturchand College of Arts, Science, and Commerce, Baramati Department of Commerce was scheduled Industrial visit of M.Com I students on 09/02/2024 as a part of project work. The visit was scheduled to Mapro Industry Pachgani. Mapro is a leading innovator in the processed food industry founded in 1959, located around the idyllic hill towns of Mahabaleshwar & Panchgani in Western India. Mapro set up a fruit processing unit at Panchgani. Mapro provided nearby farmers with technical guidance and committed to buy their produce. Tourist recognition led to the development of the Mapro Garden which defines the identity of Panchgani among tourists.

The rise of modern retail gave Mapro a nationwide network. After tax reforms Mapro invested in setting up three new units in Satara and Pune district in Maharashtra and Pathankot in Punjab. Mapro manufacture jams, fruit syrups, crushes, squashes, dessert toppings, ketchup, fruit jellies, premium chocolates and snacks.


