

Class Schedule:

Payment terms

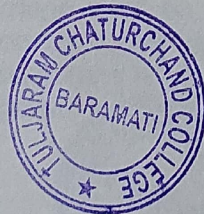

Duration

This MOU is valid from **(1st Nov, 2022) to (31th March, 2023)**. The duration of the MOU may be extended in mutual consent on expiry of this agreement.

Relationship between Parties

The Parties hereto are independent contractors. Nothing contained in this Agreement shall be deemed or construed to create between the Parties a partnership or employment or principal-agent relationship or joint venture. Neither Party shall have the authority to act on behalf of the other Party or to bind the other Party in any manner, except as expressly agreed in writing between the Parties. As between the Partner College and Anudip Foundation, all personnel engaged by the Partner College to perform activities on behalf of the College, hereunder, shall be employees or subcontractors of the College and shall not be employees of Anudip Foundation.

The Partner College shall be responsible for all acts and omissions of its personnel and any persons, agents etc. engaged by the vendor whether or not during the course of this contract and for the health, safety and security of such persons or entities and their property.

Property Ownership

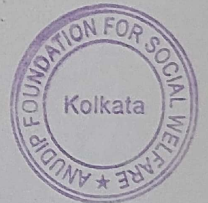
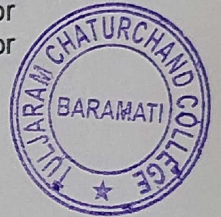

Indemnity


