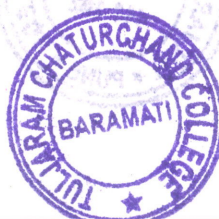

The purpose of this MoU is to create a framework for collaboration between **MBTB** and **TC COLLEGE** with the objectives as given below:

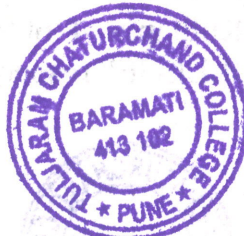
- a) To establish close linkage and functional coordination between **MBTB** and **TC COLLEGE**.

- f) **MBTB** and **TC COLLEGE** will jointly organize awareness campaigns, rallies, street plays etc., celebrate important occasions and appreciate good works by offering felicitation to the performers from time to time.
- g) **MBTB** will provide professional support to **TC COLLEGE**.
- h) **MBTB** and **TC COLLEGE** will also work in any other areas of common interest.

This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MoU upon 60 days prior written notice to the other party. It is valid till 31st March 2025 as per current renewal.
