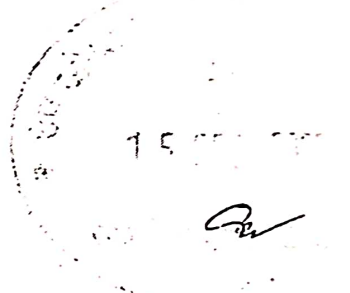

'Party')




- D) Both Parties, being legal entities in themselves desire to sign this MOU for  
advancing their mutual interest.
- E) Farm To Fork Solutions the Second Party is engaged in Business,  
Manufacturing, Skill Development, Education and R&D Services in the fields  
of consulting *FOOD, DRUGS and COSMETICS* and related fields

F) Farm To Fork solutions is a growth oriented organization run by visionary group of experienced Food Technologist, Pharmacist, Cosmetologists and diversified experts from leading institutes. We aspire to act as a connecting link amongst the Academia/ Research Organizations and various levels of the Food Chain (e.g., Farmer, Manufacturer, End Consumer, etc.) and pharmacy & cosmetic industries so as to enable the technology to reach to the stakeholders.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

**CLAUSE 1. CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.





## CLAUSE 2. SCOPE OF THE MoU

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.3 **Industrial Training & Visits:** Industry and Institution interaction will give an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party.
- 2.4 **Internships and Placement of Students:** Second Party will actively engage to help the delivery of the Internship and placement of students of the First Party into internships/jobs, as per TC College, Baramati internship Policy.
- 2.5 **Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of Food, Drugs & Cosmetics Industries such as Designing and Manufacturing of product, New Product Development, packaging Development for product, shelf life study, labeling of product etc.
- 2.6 **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and



