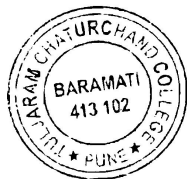

Under RUSA scheme.**

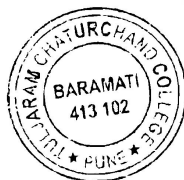
Respected Sir,
