There was a very good response from the participants across the country. Around 877 participants (including post graduate students) were registered and participated in the conference across the country.



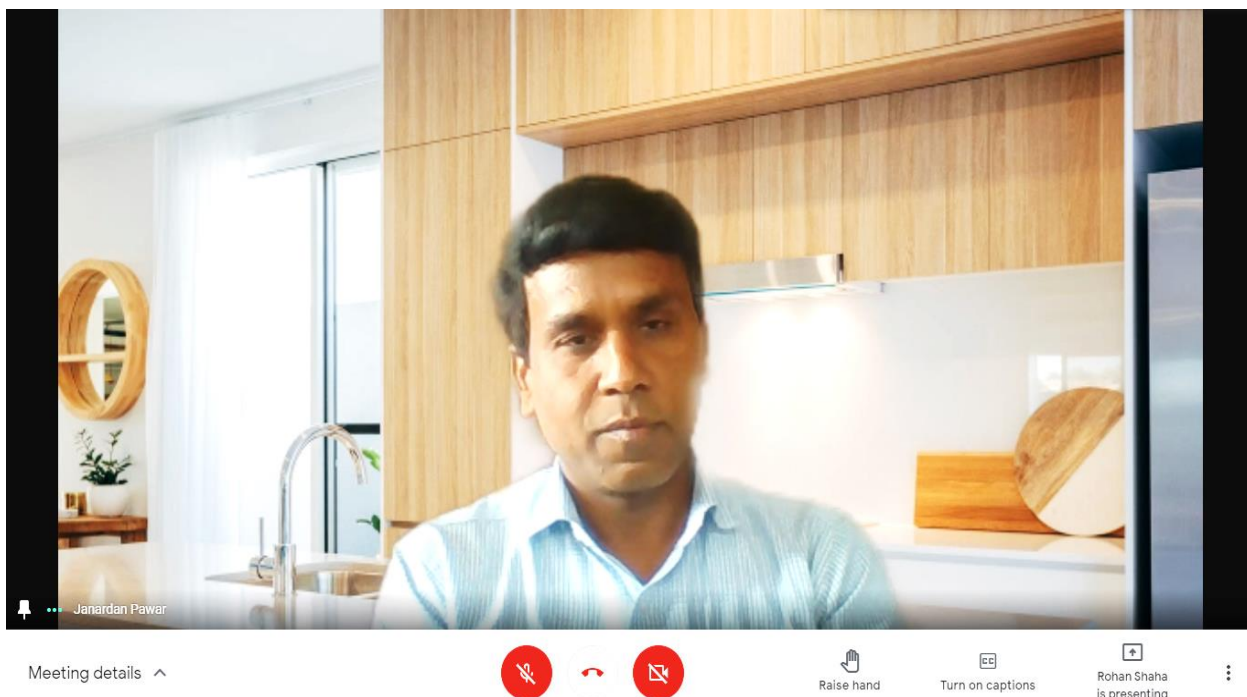

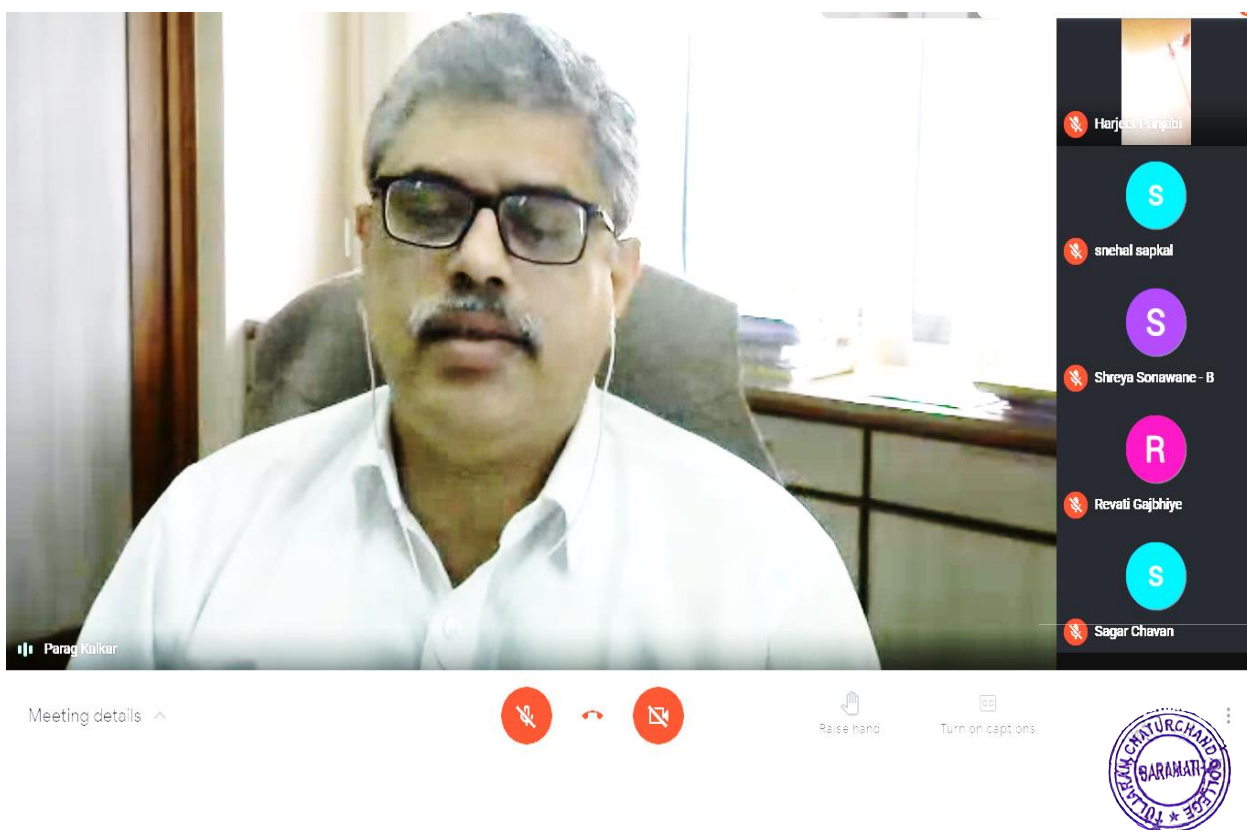

**Union Budget**

- Revenue Budget**
  - Revenue Receipts: Tax Receipts & Non Tax Receipts
  - Revenue Expenses: Expenses incurred on day to day functioning of the government & on various services offered to citizens
- Capital Budget**
  - Capital Receipts: Loans from public, foreign governments and RBI
  - Capital Expenses: Expenses incurred on development of machinery, equipment, building, health facilities, education etc

If revenue expenditure exceeds revenue receipts, the government incurs a revenue deficit.

Fiscal deficit is incurred when the government's total expenditure exceeds its total revenue. (1.5%, FY 20-21:6.8%)

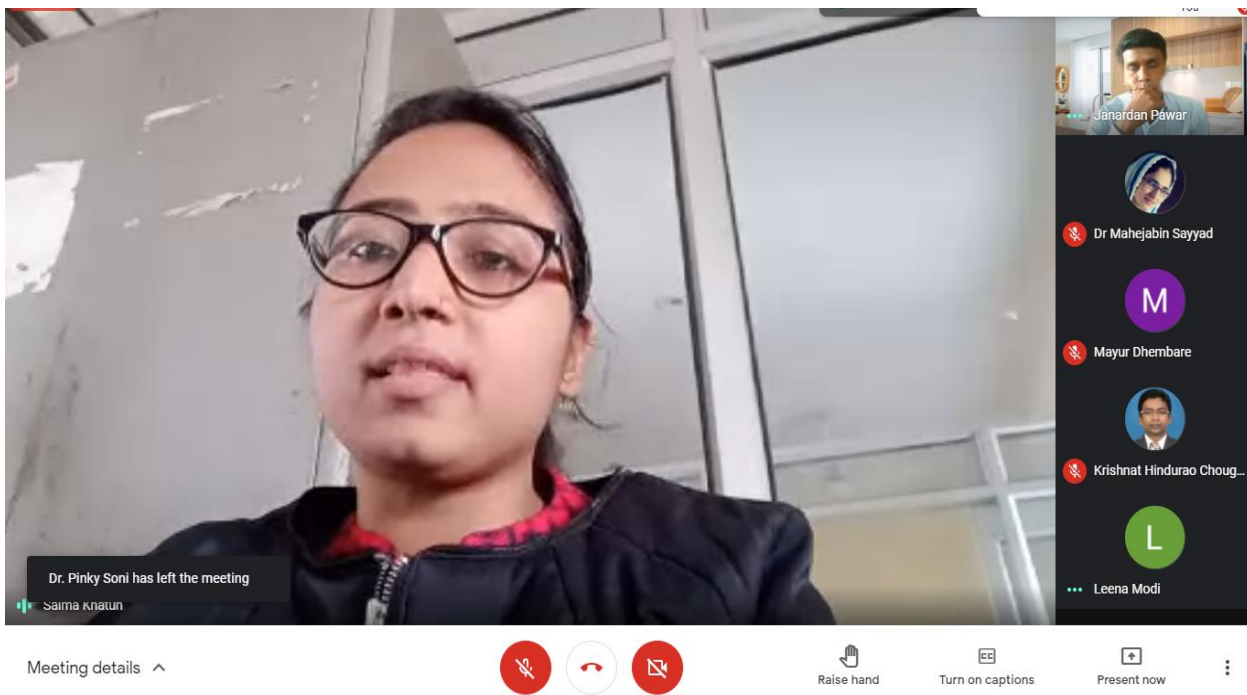

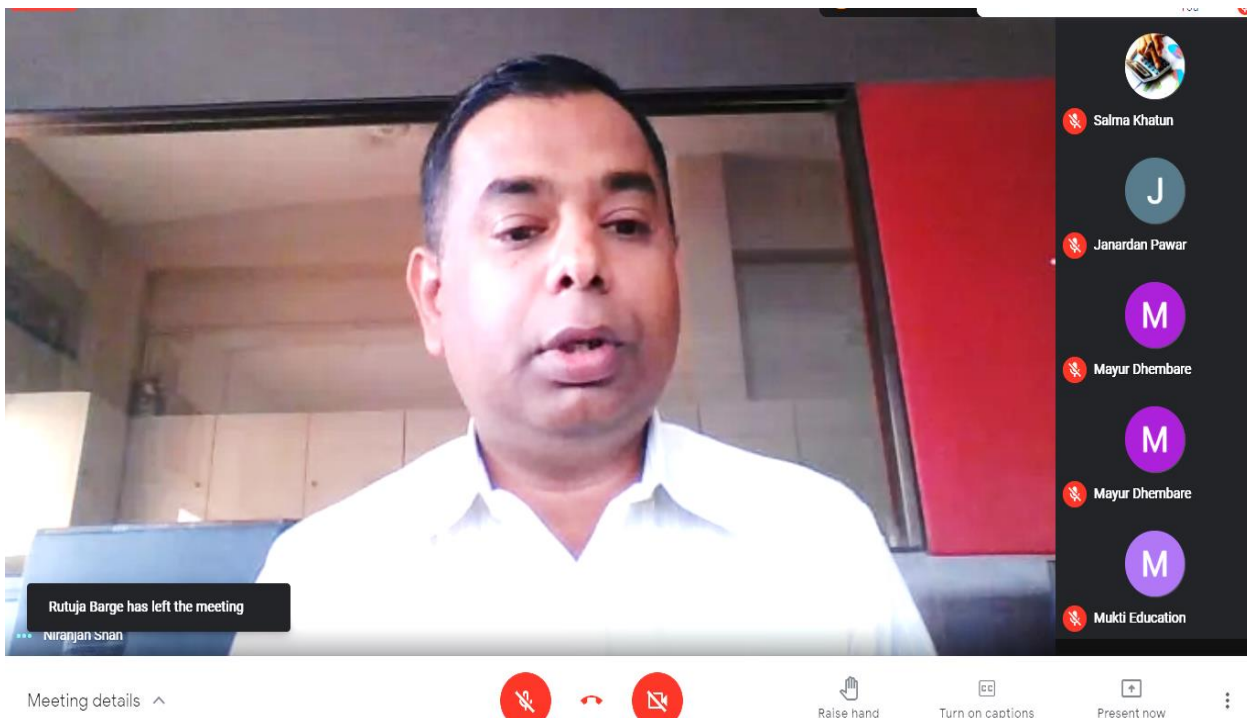


